In our efforts to sing and express beautiful music together, the time has come for each choir to be evaluated by performing in the annual **Music Performance Assessments**. This is an activity where high school choirs throughout Orange County prepare two pieces and perform them for three distinguished judges. They are evaluated on factors such as tone, blend, control, intonation, diction, technique, posture, artistry, and stage presence. They are given an overall rating that ranges from one to five, one being the highest. They must also sight read (music they have never seen before) two examples as a group in which they are given an additional rating.

Choral MPA is an incredible and memorable musical experience. **It is critical that each choir member is in attendance.** Each ensemble is a team, and when one team player is not in attendance, the entire team suffers. As stated in the chorus handbook, this activity is a **mandatory** event and each student will receive a grade for his or her involvement. After working so diligently, it would be unfortunate for a member to not to partake in this evaluation of their repertoire. Thank you for your support in this matter.
